





## Delegates

In accordance with the WDSF Statutes, each WDSF member body may be represented by up to two (2) delegates. To be accredited as a delegate, nominees must meet the qualifications outlined in Article 9 of the Statutes, as well as the Presidium's Resolutions and Operating Policies.

### Guests

The Annual General Meeting (AGM) is composed of Members' delegates, honorary members, the members of the Presidium, essential WDSF Staff and guests.

The Presidium will consider guest accreditation, including for accompanying persons, on a case-by-case basis for the 2024 AGM. Accreditation of guests beyond spouses or domestic partners will only be granted for special reasons that contribute to the AGM (e.g., interpreters or invited speakers).

The Presidium has determined that during the 2024 AGM, all guests (except interpreters and WDSF Staff) will be seated in a designated area, separate from the delegates. Guests are expected to remain in this area at all times and should not engage in conversations with delegates or interfere with the proceedings of the AGM.

## **Speakers**

Requests for guest recognition as speakers during the AGM must be submitted in writing to the General Secretary at least ten days prior the event. These requests will be considered by the Presidium before the meeting, with justifications for the application.




